CONDITIONS OF ENTRY

- Your private hire must be paid for in full 5 days prior with cleared funds if made by EFT before the commencement of your private hire.
- **A deposit of \$200.00 is payable to secure the date and time of the private hire. No refunds are given once deposits have been paid - This covers administration fees and holding fees.**
- The security bond of \$500.00 is payable prior to the start of your private hire. This fee is to be paid in cash and will be returned in cash if no damage is done to the property or equipment.
- Maximum number of patrons is **180 at any one time.**
- Additional hours will be determined based on requirement.
- No alcoholic drinks are permitted unless a limited license from the liquor commission is supplied, at your cost and supplied to Little Rockets Play Café Barossa prior to the start of your private hire/function.
- No equipment will be plugged in unless it has a current in-date electrical test and tagged compliance attached.
- All party rooms are out of bounds.
- You will be responsible for controlling patron entry for the duration of the private hire/function.
- All party guests must wear socks; no bare feet or shoes are to be worn in the playground. Socks can be purchased from Little Rockets Play Café Barossa if required.
- Parents, guardians, carers must always supervise their children. The toddler area is for children under the age of 3. The main play structure is for children 4+ years.
- Any injuries must be reported to the Little Rockets Play Café Barossa staff members. An incident report may be required to be completed.
- It is understood that physical activity can often result in injury, and no patron will hold Little Rockets Play Café Barossa, Little Rockets Play Café Pty Ltd, Barossa Play Hub Pty Ltd, The G & D Payne Family Trust, staff or nominee or any other entity responsible should any injury occur.
